MINOR'S SKATEBOARD, DIRTBIKE & OTHER PLANET DIRT ACTIVITY WAIVER, RELEASE OF LIABILITY & AGREEMENT TO INDEMNIFY

In consideration of the services provided by Training Wheels of NE, Inc dba Planet Dirt, their agents, officers, participants, consultants, employees, and all persons or entities acting in any capacity on their behalf (hereinafter referred to as Planet Dirt) I now agree and certify as follows:

1. I acknowledge and fully understand that I, the participant, will be engaging in activities that may involve risk of serious injury which might result not only from my own actions, inactions or negligence, but from the actions, inactions or negligence of others or the conditions of the premises or of any equipment used. Further, that there may be other risks not known or not reasonably foreseeable at this time. The risks may include, but are not limited to: nature of the activity; latent or apparent defects or conditions in equipment or property supplied by Planet Dirt, or other persons or entities; use of property by myself or others or use of equipment supplied by Planet Dirt or other entity; acts of other participants in this activity, employees or agents of the Planet Dirt; my own physical condition, acts or omissions; conditions of the Planet Dirt facility and surrounding grounds or terrain and accidents connected with their use; first aid emergency treatment or other services.
2. I expressly agree and promise to accept and assume all the risks existing in this activity. My participating in this activity is purely voluntary and I elect, in spite of the risks, to participate. I assume all the foregoing risks and accept personal responsibility for the damages following such injury.

On behalf of myself, my children, my parents, my heirs, assigns, personal representatives I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless Planet Dirt, of their respective commissioners, directors, agents, and other employees, its parent, subsidiaries, affiliates, employees, distributors and agents, other participants, and, if applicable, operator or lessors of premises used to conduct the event/activity, from any and all liability for any and all claims, demands or causes of action which are in any way connected with my participation in this activity or my use of the Planet Dirt equipment or facilities.
